# **DISCUSSION / ACTION ITEMS**

1. DISCUSS, CONSIDER AND ACT UPON THE REGULAR MEETING MINUTES FOR MARCH 20, 2019.

Treasurer Bochniak made a motion to approve the March 20, 2019 Regular Meeting Minutes. Seconded by Vice-President Weeks. President Shatter called for a vote. All voted in favor. The motion passed unanimously

2. DISCUSS, CONSIDER AND ACT UPON THE MARCH 2019 FINANCIAL REPORTING, AND RELATED FINANCIAL ITEMS.

Finance Assistant Phyliss Moore presented the updated March 2019 financials as we didn't meet in April. Due to meeting being held early in the month, finance couldn't get April financials this month. Treasurer Bochniak made a motion to approve the March 2019 financials as reported. Seconded by Secretary Cash. President Shatter called for a vote. All voted in favor. The motion passed unanimously.

3. DISCUSS, CONSIDER AND ACT UPON THE 2018-2019 MID-YEAR BUDGET. Finance Assistant Phyliss Moore stated there were changes made to the mid-

Finance Assistant Phyliss Moore stated there were changes made to the midyear budget since the Board approved it. There were items removed from the original changes as the budget would be able to absorb them and no need to change. Treasurer Bochniak motioned to approve the 2018-2019 mid-year budget with changes. Seconded by Vice President Weeks. President Shatter called for a vote. All voted in favor. The motion passed unanimously.

4. DISCUSS AND CONSIDER THE 2019-2020 BUDGET.

Finance Assistant Moore stated that President Shatter, Treasurer Bochniak, and Director Anderson met and went over the 2019-2020 budget. The recommended

decreasing the promotional services item; increasing office supplies; increasing dues and subscriptions; increasing the transfer in to the Town; and increasing capital improvements.

Director Anderson stated there was not a need to adopt the budget as there are some other items that may be changed.

Director Anderson stated she was hiring an Executive Assistant. There were 18 applicants and it was narrowed down to 10 for further screening. Hope to have someone on board end of May or beginning of June.
